Government of Telangana vide 1<sup>st</sup> reference cited, have accorded permission to conduct the 2<sup>nd</sup> Edition of Chief Minister's Cup 2025 in various disciplines in Sub-Junior, Junior, Senior age categories including Para Games at Gram Panchayat, Mandal / Urban Local Bodies (ULBs), Assembly Constituency, District & State levels. **Assembly Constituency level competitions debut in the 2<sup>nd</sup> Edition of Chief Minister's Cup 2025.** The objective of the Chief Minister's Cup is to encourage, promote sports from grassroot level, scout the talent from rural and craft champions at Global Level with a vision to target for achieving medals at the Olympics 2036.

The 2nd Edition of Chief Minister's Cup Competitions shall be conducted as per guidelines of the National Sports Federation in consultation with the respective State Sports Associations in order to align with national norms while scouting the young talent from the grassroots.

The detailed schedule and guidelines of the 2nd Edition of Chief Minister's Cup 2025 are as follows:

Recreational Games shall be conducted for encouraging Physical Literacy among the citizens.

**Note:**

- **PD / PET will be in charge of a cluster area for conduct of Games in all Gram Panchayats.**
- **Cluster area consists of a group of Gram Panchayats.**
- The Gram Panchayat level committee shall be responsible to ensure that Online Registrations of players is completed before their participation in any of the competitions.
- At Gram Panchayat level, HM / Principal in consultation with PET / PD shall be the overall in charge to organise and conduct competition. The concerned HM / PET / PD shall be responsible for sending the Gram Panchayat level selected players / teams to Mandal (Rural) Competitions.
- For Gram Panchayat level competitions, the Committee shall ensure Identification and Preparation of Play Fields, Banners / Flexis, Sports Material, Public address system (Mike), Chairs & Table, Tent, Prizes, Drinking Water, Medical Facilities, Sports Certificates (Model is enclosed), etc.
- The Gram Panchayat level committee shall identify the talented players not participated in the disciplines notified by the District Collector (due to shortage of the players in the particular disciplines), and send to the Mandal (Rural) / Municipality / Zonal level for Corporations.

- The Gram Panchayat level committee shall also be responsible to send the talented players directly to Assembly Constituency Level competitions for those disciplines that are not conducted at Mandal (Rural) / Municipality / Zonal level for Corporations. Likewise, the gram panchayat level committee shall also be responsible to send the talented players directly to District Level competitions for those disciplines that are not conducted at Assembly Constituency Level.
- The Gram Panchayat level committee shall be responsible to conduct competitions at all the Gram Panchayats.
- The Participation certificates shall be downloaded from the SATG portal.

- The above said committee shall invite the eminent sports persons from the concerned District to encourage and motivate the players during the competitions.

- MEO in consultation with the committee, shall send the selected players / teams accompanied by PDs / PETs, for participation in Assembly Constituency Level Competitions.
- Women Teams shall be accompanied by Women Officials only.
- The Committee shall mobilize the local Sponsorship funds through CSR, Philanthropists, local contribution for providing of amenities, Sports Material etc., to encourage the Players.

- The District Level committee shall ensure for Identification and Preparation of Play Fields, to provide the Sports Material, Banners / Flexis, Public address system (Mikes), Chairs & Table, Tent, Prizes, Drinking Water, Medical facilities, Sports Certificates (Model is enclosed), etc.
- The Secretary / President of the District Associations have to inform to the players of concerned disciplines regarding competitions at Village, Mandal, Assembly Constituency, District level.
- The Secretary / President of the District Olympic Association shall coordinate with the district authorities, district sports associations, stakeholders to inform regarding competitions at village, Mandal, Assembly Constituency, District level.
- The above said committee shall invite the eminent sports persons from the concerned District to encourage and motivate the players during the competitions.
- Each Women team of Districts shall be accompanied by one Woman Official i.e., Coach or Manager for State Level competitions.
- The Committee shall mobilize the local Sponsorship funds through CSR, Philanthropists, local contribution for providing of amenities, Sports Material etc., to encourage the Players.

- District Level organizing committee shall form a Technical / Selection committee for each discipline with the members of concerned discipline coach, Secretary of concerned District Association / Senior player of concerned discipline. Any member may be co-opted by the committee, if required.

- District Level Committee shall be responsible to conduct the Competitions and the selection committee shall select the best players for team games at District level to participate at State Level competitions, with the help of concerned Coaches, SGF Secretary, person in charge of universities sports wing, concerned disciplines technical officials, District Association Secretaries.
- DYSO in consultation with the committee shall send the particulars of the selected players / teams discipline wise to DYSOs immediately after completion of Competitions at District Level, along with Players & accompanying Officials details and upload the results sheets duly signed by them in the SATG portal.
- The above said committee shall be responsible to ensure that Online Registrations of players is completed before their participation in any of the competitions.
- DYSO shall bring the District Teams and ensure that the teams are accompanied by PDs / PETs / concerned discipline Association members, for participation in State Level CM's Cup Competition. Each team shall be accompanied by one official i.e., Coach cum manager.
- The DYSO shall send the selected final strength particulars of players and accompanying officials of the District teams, discipline wise after coaching camp to SATG immediately.
