I invite your attention to the references cited, wherein Government have accorded permission to conduct the **2nd Edition of Chief Minister's Cup 2025** at **Gram Panchayat, Mandal / Municipality / Zonal, Assembly Constituency, District and State levels** in a prestigious manner, with a vision ***"Rural to Global - Crafting Champions"***.

As per the approved schedule, the competitions are to be conducted during **January and February 2026**, as detailed below:

- **Gram Panchayat Level:** 17th to 22nd January 2026
- **Mandal (Rural) / Municipality / Zonal Level:** 28th to 31st January 2026
- **Assembly Constituency Level:** 03rd to 05th February 2026
- **District Level:** 09th to 12th February 2026
- **State Level:** 20th to 23rd February 2026

The successful conduct of the Chief Minister's Cup largely depends upon the active involvement and coordination of the **Physical Education Teachers (PETs), Physical Directors (PDs) and Mandal Education Officers (MEOs)**, who have been assigned key responsibilities at various levels, including organization of competitions, mobilization of players, online registrations, escorting teams, preparation of playfields, uploading of results and adherence to the prescribed guidelines.
